**Membership Payment Types:**

Monthly Autorenew Memberships – This membership has a 2-month minimum commitment and can be cancelled at any time after two billing cycles. Monthly dues will begin on the date of enrollment and be processed monthly until the membership has been cancelled by the participant or if the payment method fails.

Quarterly Autorenew Memberships – This membership has a 3-month minimum commitment and can be cancelled at any time after the first billing cycle. Quarterly dues will begin on the date of enrollment and be processed every 3 months until the membership has been cancelled by the participant or if the payment method fails.

One Year Commitment Monthly Installment Membership – This membership has a 12-month minimum commitment and can be cancelled at any time after the 12<sup>th</sup> billing cycle. Monthly payments will begin on the date of enrollment and be processed monthly until the membership has been cancelled by the participant. If the payment method for monthly dues fails to process, Windsoul Wellness Center will reattempt the charge every 48 hours for up to three additional attempts before the membership is terminated.

Paid in Full Memberships – Must be paid in full on the date of enrollment and will auto-renew at the end of the membership.

Class Passes – These memberships must be paid in full on the date of enrollment and will not auto-renew at the end of the membership. Class Pass memberships are valid for 12 months from the date of purchase.

By signing this agreement, you are authorizing Windsoul Wellness Center to debit your bank account (EFT) or charge your credit card for your membership dues according to the membership payment terms listed above.

Consumers Right to Cancellation: You may cancel this contract without penalty or further obligation by submitting a cancellation request within three (3) business days of the date of this contract or the date of your receipt. Cancellation requests must be submitted in writing by email to info@windsoulwellnesscenter.com or with a written letter postmarked within three (3) business days of the contract date sent to 11 Progress Ave, Tyngsboro, MA 01879.

In addition, Windsoul Wellness Center may refuse for any reason the renewal of any member’s membership.

It is expressly agreed that all use of Windsoul Wellness Center, LLC facilities and premises (including but not limited to parking areas, walkways, driveways, etc) shall be undertaken by the member at his or her sole risk and Windsoul Wellness Center, LLC shall not be responsible or liable for loss or damage to any other property of members or their guests, including but not limited to their automobiles and contents. It is also agreed that damages to Windsoul Wellness Center, LLC facilities or properties or to the properties of any member by another member or their guest, is the sole responsibility of the offending member.
